# MetaZonic (MZC): The Decentralized Crypto-Equity Token

With a max supply of 10,000,000 tokens and liquidity available on PancakeSwap, MetaZonic seeks to attract traders who want equity-like exposure in the DeFi space without relying on centralized brokers.
